New Version of mLINQS Government Relocation Expense Management Software Ensures Users Remain in Full Compliance

FAIRFAX, VA – (July 19, 2016) – mLINQS, LLC today announced that the company has released a new version of its award winning federal employee relocation expense management software system, moveLINQ v8.2, for general availability. This new version ensures federal agencies using the software will be fully compliant with the latest General Services Administration (GSA) reporting requirements as referenced in the GSA Federal Travel Regulation Bulletin, [FTR 16-04](#), dated May 26, 2016, as well as other important enhancements.

“This new version of moveLINQ provides our customers with a turnkey report required by GSA and the Office of Management and Budget (OMB) to report employee relocation data for fiscal years 2013 through 2015,” said Greg McIntyre, President, mLINQS. “It automates the entire process to generate an accurate report quickly and easily with little impact on agency resources. Version 8.2 also includes an enhancement that supports an earlier amendment to the Federal Travel Regulation (FTR) that enables our customers to collect any Withholding Tax Allowance (WTA) previously paid to a transferee who has not filed a ‘Statement of Income and Tax Filing Status’ in a timely manner. This will be a major contributor to agencies in their effort to prudently manage taxpayer funds. As with all updates to moveLINQ, our customers will receive the new version at no charge.”

The GSA report contains 11 separate categories of transferee payments made by a federal agency or department each fiscal year. All of these data are stored electronically in moveLINQ, and can be accessed through the software’s standard menu. In turn, GSA uses the information to help develop future relocation policy and to report overall employee relocation expenses to OMB. The new software enhancement enabling agencies to recoup WTAs from employees who are not compliant helps to streamline the Relocation Income Tax Allowance (RITA) process, potentially saving moveLINQ customers time and unnecessary expenses.

moveLINQ is the only fully compliant, Web-based government employee relocation expense management system. Developed by mLINQS staff in 2004, it is used to support relocation for the employees of over 35 federal agencies, including 11 of the 15 federal executive departments. mLINQS managed hosting service customers have access to the system 24X7 in a federally-compliant IT infrastructure designed and maintained to achieve Authority to Operate (ATO) in accordance with Assessment & Authorization (A&A) standards for federal agency requirements. mLINQS also offers a unique Reporting Portal that enables users to create and maintain custom relocation reports for trend analysis, budgeting and policy decisions, and to respond promptly to management or FOIA requests.
